

DONATION AGREEMENT

This Donation Agreement (herein the “Agreement”) is made effective on January 1, 2020 (“Effective Date”), by and between Ameri-Tex Services, Inc., a Texas Corporation (“Ameri-Tex”), and Cancer Foundation For Life, Inc. a Texas nonprofit corporation (“CFFL”).

WHEREAS, Cancer Foundation For Life, Inc. dba FitSteps for Life, is a Texas nonprofit corporation whose address is 218 N. College, Tyler, TX 75702; and

WHEREAS, CFFL is a pioneer and leader in cancer exercise treatment; prescribing individualized and structured exercise treatment specifically for patients. It is the only known community-based program that is provided free for the lifetime of the patient; and

WHEREAS, Ameri-Tex desires to support the mission of CFFL and the services provided by CFFL to cancer patients in the East Texas Region by donating a portion of proceeds received by Ameri-Tex from the sale or lease of pink trash bins to Ameri-Tex customers; and

WHEREAS, Ameri-Tex seeks to ensure that 100% of the money donated to CFFL is utilized for cancer diagnosis, treatment, awareness, or assistance to families whose member(s) are diagnosed with cancer, and that any such donated funds from Ameri-Tex are utilized in the East Texas Region.

THEREFORE, in consideration of the mutual promises made in this Donation Agreement, the sufficiency of which the Parties acknowledge, the Parties agree as follows:

1. **No Obligation to Donate.** Nothing in this Donation Agreement requires Ameri-Tex Services, Inc. to donate any time, money, or other resources to CFFL, and nothing in this Agreement requires Ameri-Tex to make any accounting to CFFL of the finances of Ameri-Tex Services, Inc.; it being understood that Ameri-Tex intends to donate to multiple cancer-related non-profit corporations within the East Texas Region. However, if and when Ameri-Tex Services, Inc. donates money to CFFL, this Agreement shall govern the use of such donations by CFFL.
2. **Use of Donated Proceeds.** CFFL agrees to utilize 100% of the money donated by Ameri-Tex Services, Inc. for expenses related to cancer diagnosis, treatment, awareness, or assistance to families whose member(s) are diagnosed with cancer, in accordance with the mission of CFFL and at the direction of its Board of Directors. Further, CFFL agrees to utilize 100% of the money donated by Ameri-Tex Services, Inc. within the East Texas Region.


3. **Accounting.** Upon written request of Ameri-Tex Services, Inc., CFFL shall respond and certify in writing within sixty (60) days that (i) 100% of the money donated by Ameri-Tex Services, Inc. has been utilized for the purposes set forth in this Donation Agreement and that (ii) all donated money from Ameri-Tex Services, Inc. has been utilized within the East Texas Region.

4. **Definitions.** For the purpose of this Donation Agreement, the term "East Texas Region" shall mean any Texas county that is east of Dallas County and north of Harris County.


